I agree that I will not sell, give away or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity for any reason. If at a later date I am unable or unwilling to keep this pet, I agree to first contact the above described current owner and give them the option to reclaim said pet at no charge.

I hereby agree that this animal shall not be used for purposes of breeding, experimentation, or as a food source for humans or other animals.

By signing this contract I agree to scheduled home visits either by the rescue person(s) from which I am adopting and/or designated agent to ensure the health and well-being of said animal.

I hereby agree to care for the above described pet in a humane and responsible manner and to provide it with clean and adequate shelter, food, water and veterinary care. I further agree that said pet shall reside inside my home or outside with adequate shelter and sufficient fencing and shall not be allowed to roam freely.

I hereby agree that the adoption fee of \$ _____ helps to cover the current owner’s expense of raising and caring for the animal and is not refundable.

I hereby understand and agree that the current owner makes no representations or warranties, expressed or implied, about the above mentioned animal's temperament and is hereby absolved from any liability for future damages or injuries caused by said animal. I also understand and agree that the current owner further gives no guarantees, expressed or implied, of the suitability of the animal to the adopter and/or his family.

Finally, by signing this contract I understand and agree to relinquish this animal without interference in the event that the rescue person or other recognized animal control agency determines that there is evidence of inhumane or improper care. _____ (initial here)

Saving Animals & Healing Hearts Inc can provide local hospital/clinic information to assist in veterinarian experienced with pigs at no cost to you.

I understand that by voluntarily signing this agreement, I am entering into a legal and binding contract with Saving Animals & Healing Hearts Inc. Breach of any term(s) of this agreement is actionable by SAHH. In the event there is a violation of the agreement, I agree to pay all costs associated with reclaiming/returning this animal to SAHH. Additionally, in order to facilitate the collection of damages for breach of contract, I waive any challenge to venue and agree that the appropriate venue for this matter is the Commonwealth of California, and the County of San Diego. Furthermore, I agree to accept service of process by certified mail, return receipt requested, to the address provided in this adoption contract, and specifically waive any right to receive personal service.

I certify that I have read and understand the terms of this Adoption Contract. I acknowledge that failure to comply with these terms shall be considered a breach of contract and shall result in the immediate return of the adopted pet to Saving Animals & Healing Hearts Inc and may civil penalties
